The Portfolio is designed to provide risk adjusted returns. It aims to achieve capital appreciation and reduce investment risk through diversification across asset classes and geographies.

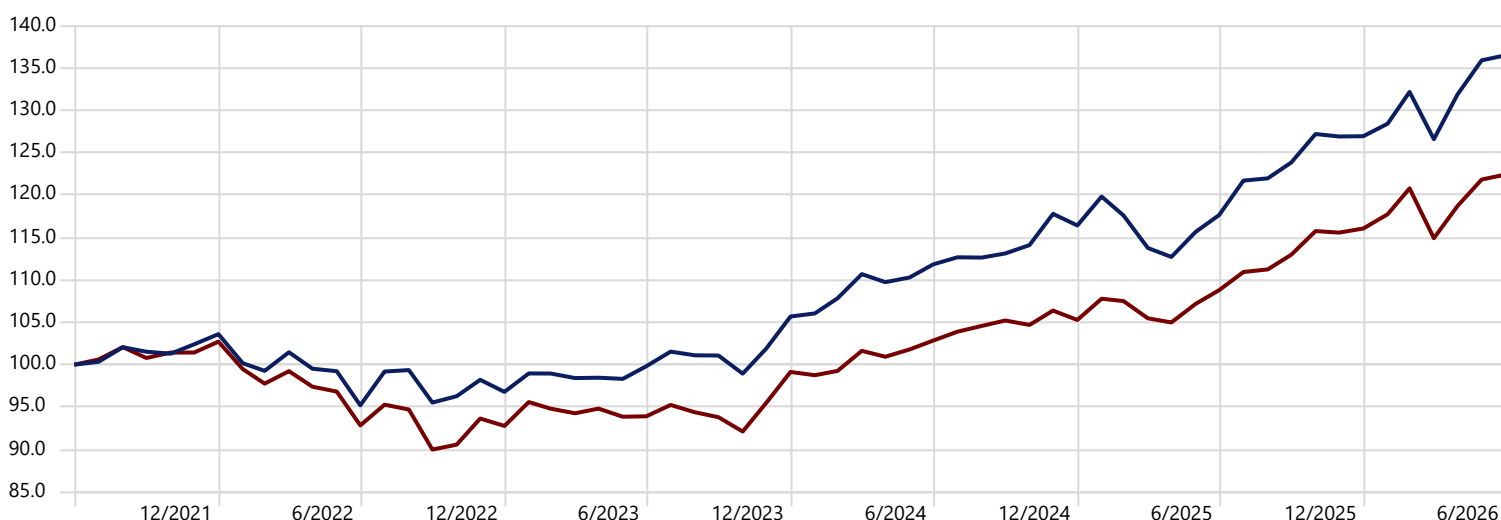

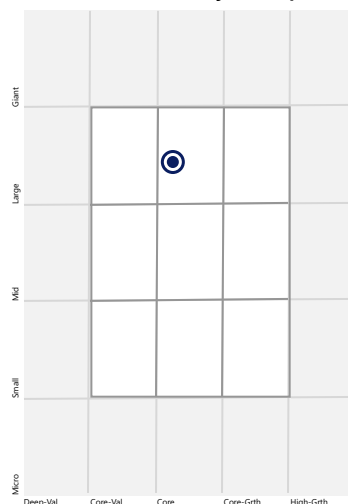

Dimensional is a leading global investment firm that has been translating academic research into practical investment solutions since 1981.

Global markets extended their rally in May, with US stocks leading the advance as the Russell 3000 Index gained 5.9%, driven primarily by large-cap technology and continued enthusiasm around artificial intelligence. Overall, the Information Technology sector gained 17.3% as giants like Apple and Microsoft both posted double digit returns and Micron Technology returned 89%. However, performance was much more muted in other sectors as Energy, Utilities, and Consumer Staples sectors declined by -5.3%, -3.9% and -2.6%, respectively, for the month of May.

Outside the US, markets delivered solid returns with other developed markets up 3.8% as measured by the MSCI World ex USA IMI Index (net div.) and emerging markets outperforming as the MSCI Emerging Market IMI Index (net div.) returned 9.7% for the month, led by strong returns from Korea, which returned over 30% as well as Taiwan, which returned 17.9%.

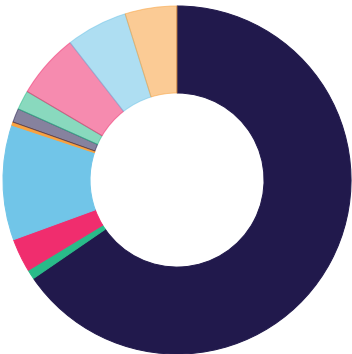

Target Market
