The Portfolio is designed to provide risk adjusted returns. It aims to achieve capital appreciation and reduce investment risk through diversification across asset classes and geographies.

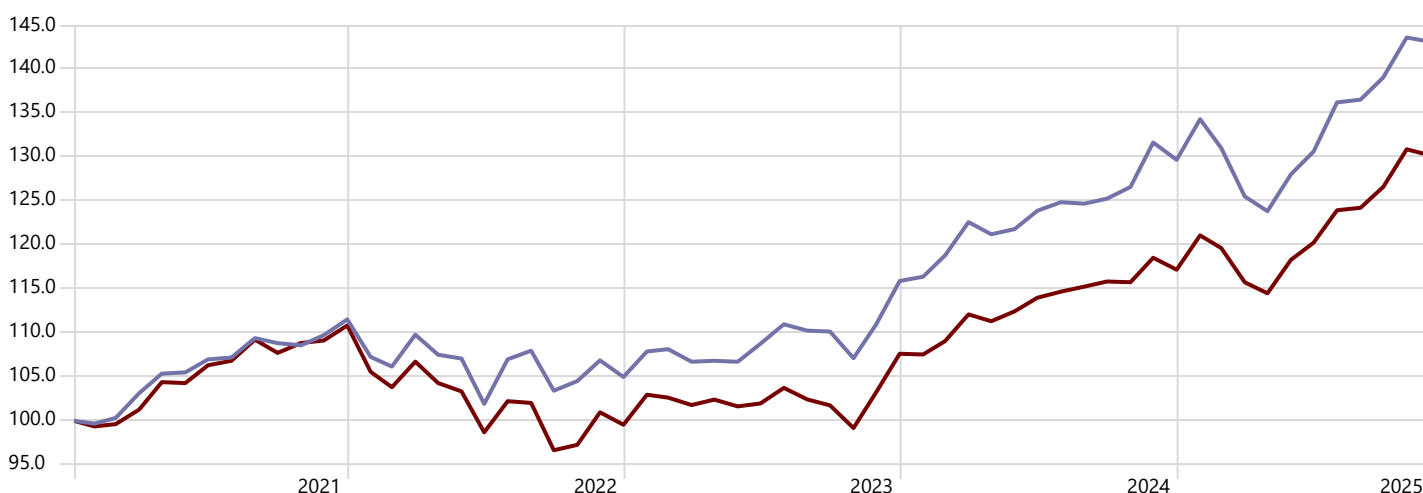

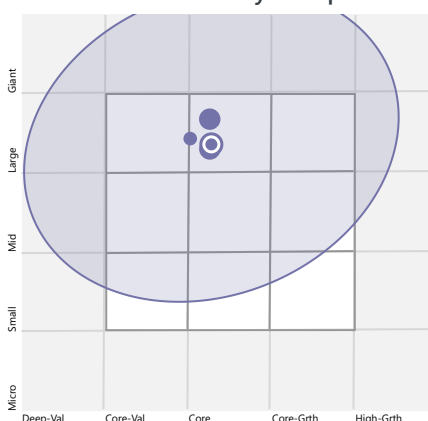

Investment Adviser's Market Commentary



US stocks delivered strong returns in September as the Russell 3000 Index rose 3.82%. During their September meeting, the US Federal Reserve cut rates by a quarter of a percent, their first rate cut in 2025. Technology stocks, fuelled by continued excitement around AI, rose even further as the Nasdaq Composite Index gained 6.05%. The end of the month saw the prospect of a US government shutdown loom, but the market continued its gains going into the end of the month. Small cap stocks, which had rebounded in August, had more modest gains in September, with the Russell 2000 Index up 3.48%.

Dimensional is a leading global investment firm that has been translating academic research into practical investment solutions since 1981.

Globally, developed markets outside the US slightly underperformed the US market, with the MSCI World ex USA IMI Index (net div.) up 2.50% for the month of September. However, the index has far outpaced broad US indices for the year, gaining 17.16% year-to-date while the Russell 3000 Index is up 6.42%. Emerging markets saw the strongest returns, as the MSCI Emerging Markets IMI Index (net div.) gained 6.79% in September, led by strong returns from Korean and Chinese markets, and 17.17% year-to-date.

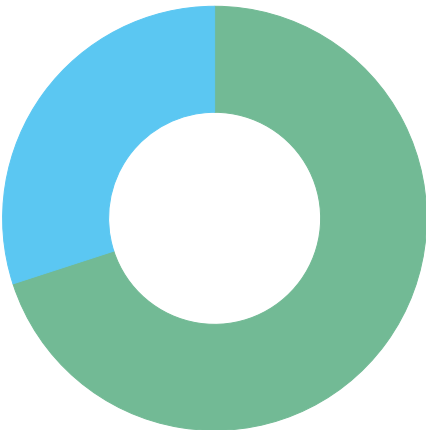

Asset Allocation

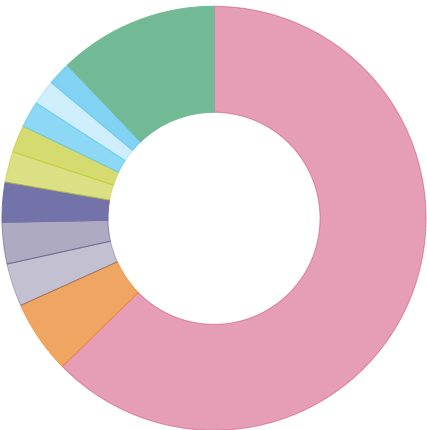

Target Market
