

## Fairstone Systematic Model 7 powered by Dimensional

### Investment Aim

The Portfolio is designed to provide risk adjusted returns. It aims to achieve capital appreciation and reduce investment risk through diversification across asset classes and geographies.

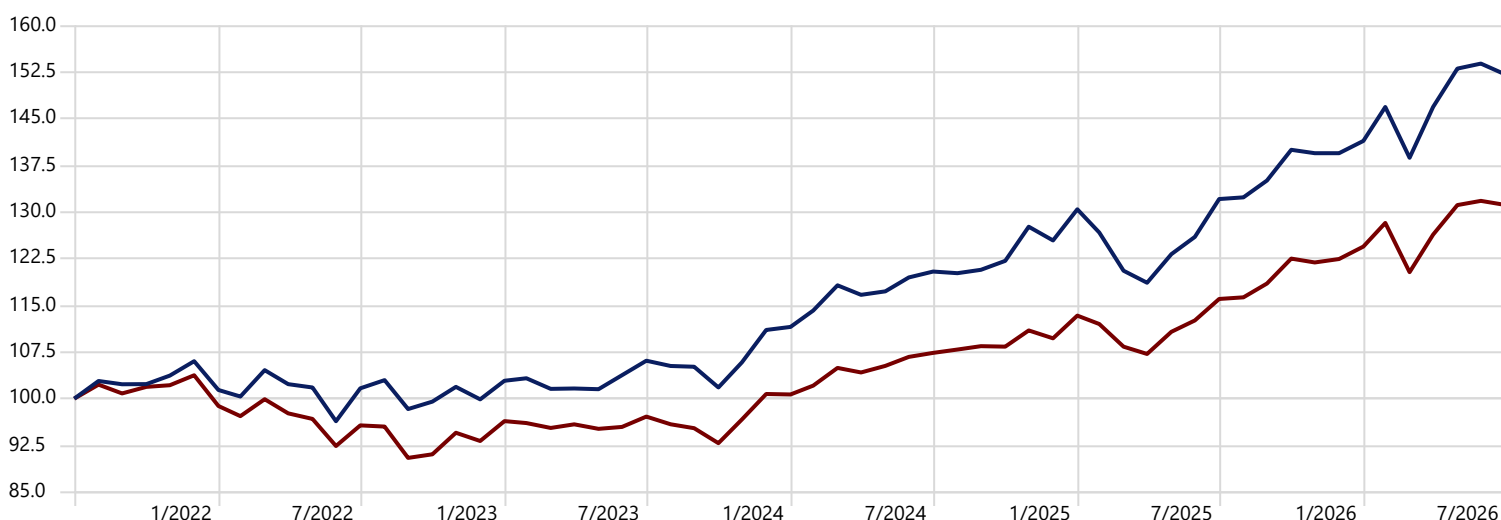

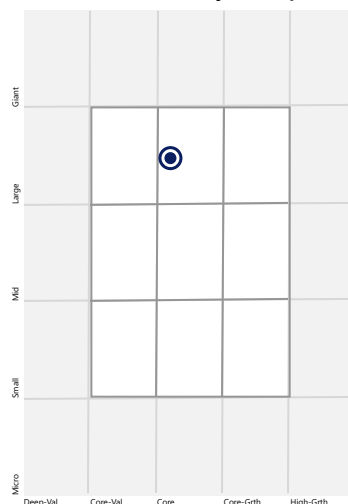

## Investment Adviser's Market Commentary



Global equity markets produced mixed results in June as investors navigated ongoing geopolitical uncertainty and significant volatility in energy markets. In the US, the Russell 3000 Index gained 1.3% for the month while developed markets outside of the US gained 0.5%, in GBP terms. Emerging markets lagged with the MSCI Emerging Markets IMI Index (net div.) declining 0.1% through June. Communication services was the worst performing sector during the month, and energy also declined as oil prices fell sharply.

Dimensional is a leading global investment firm that has been translating academic research into practical investment solutions since 1981.

The month was marked by shifting sentiment surrounding the conflict in the Middle East, which contributed to large swings in oil prices and commodity markets. Despite weakness in June, equity markets finished a strong second quarter, with the S&P 500 Index posting its best quarterly gain since 2020, and emerging markets outperforming both the US market and developed markets outside of the US for the quarter.

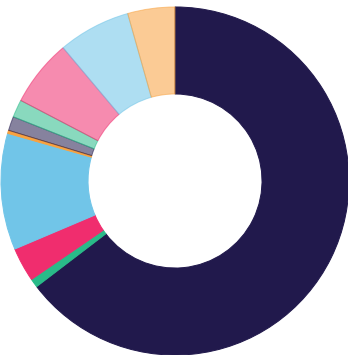

## Target Market
