Investment Aim

The portfolio is designed to provide risk adjusted returns. It aims to achieve capital appreciation and reduce investment risk through diversification across asset classes and geographies.

## Investment Adviser's Market Commentary

In December, overall, global stock markets stayed mostly flat. But growth is spreading more widely beyond the large technology names. European stocks performed well, while emerging markets delivered a strong finish to the year. In Southeast Asia, companies are increasingly benefiting from the rollout of artificial intelligence, both in building the technology and applying it at scale in areas like banking and payments. We continue to see emerging markets as a valuable long-term opportunity; these regions are home to businesses driving innovation and expanding access to essential services.

In the US, the Federal Reserve cut interest rates by 0.25% during the month. The vote to cut rates was split, and the divide points at a challenge currently faced by both the US and UK central banks: inflation remains above target, but the economy isn't significantly growing outside of the AI story. While we expect interest rates in both regions to gradually decline, the path is likely to be uneven. With that in mind, we remain cautious in our approach to interest rate risk. This means focusing more on shorter maturity bonds that should be better protected if interest rates move unexpectedly.

## Fund In Focus

### Pictet Water

A concentrated global equity fund focused on companies offering solutions to global water challenges.

Urbanization, population growth and climate change are placing growing pressure on global water resources. This fund seeks out companies aiming to address this challenge through water supply, treatment and distribution, wastewater treatment and water quality monitoring.

When assessed against the planetary boundaries framework, the fund manager's analysis finds that companies within the fund have a positive impact on freshwater use, eutrophication and chemical pollution.

## Tribe Commitments

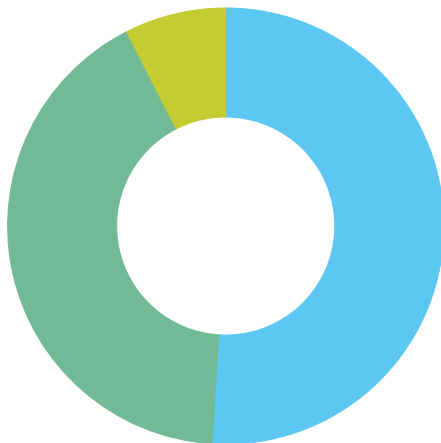

## Asset Allocation

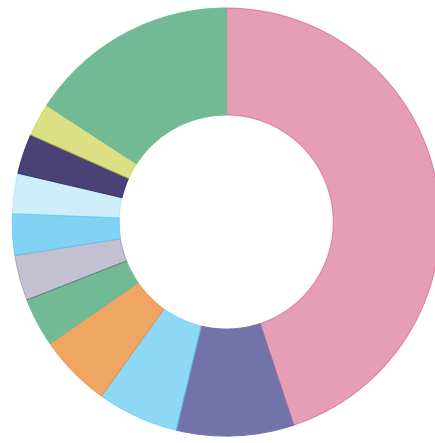
